FROM OUR CHAIR



Welcome to this celebration of the success of The Ohio State University Wexner Medical Center Department of Emergency Medicine in 2020. Mark Angelos, MD, retired as the third chair of our department in January 2020. We owe him a tremendous amount of thanks and gratitude for his service and years as chair, but also for his 29 years of service to the department and the university. Congratulations, Mark, and happy retirement!

As I assume the role of chair, I'm particularly grateful for the accomplishments and skill of our faculty, emergency medicine and emergency medicine/internal medicine residents, fellows and advanced practice providers. Last year, we provided care to 128,782 patients who visited our two emergency departments and two after-hours clinics. There

have been a number of innovative clinical accomplishments, including the expansion of our MAT program for opioid-dependent patients, as well as new video visits for our after-hours clinics.

We continue to grow with now 60 emergency medicine faculty. This past year, we added faculty members who had completed their fellowships in ultrasound, education and research. We have national experts across the mission areas contributing to the development of new knowledge, educating the next generation of emergency physicians and delivering cutting-edge emergency care.

In research, we've increased our NIH funding and are now 14th in the country, with over \$1.4 million in funded research. We have five faculty principal investigators on federally funded projects. In education, we recruited seven fellows (two ultrasound, two EMS, one medical education, one administration and one research), as well as 19 emergency medicine residents, including two EM military and two EM/IM residents.

Department physicians led the way in many aspects of the medical center and university's disaster response to the COVID-19 pandemic. Dan Bachmann, MD, set up central Ohio's first and most productive swab station. Nick Kman, MD, and others created an online curriculum for medical students, and our clinical leadership, including Eric Adkins, MD, Michael Dick, MD, and Mark Conroy, MD, adapted our clinical operations in an ever-changing environment. The entire physician and APP group worked collaboratively with our nurses, pharmacists and support staff to see us through the worst of COVID-19.

As we enter the next year, we'll continue to face challenges, including the ongoing COVID-19 pandemic, and the need to focus on identifying and attacking racism and social justice issues in our communities, workplace and our own lives. The university and the The Ohio State University College of Medicine have developed comprehensive initiatives, and the department will be a leader in this area. To start, we've formed a diversity and inclusion committee, and have announced a national search for a vice chair of Diversity and Inclusion.

Despite the challenges of the past year and going forward, Ohio State's Department of Emergency Medicine continues to produce exceptional research, educational initiatives and clinical care. We look forward to continuing our successes in the coming year.

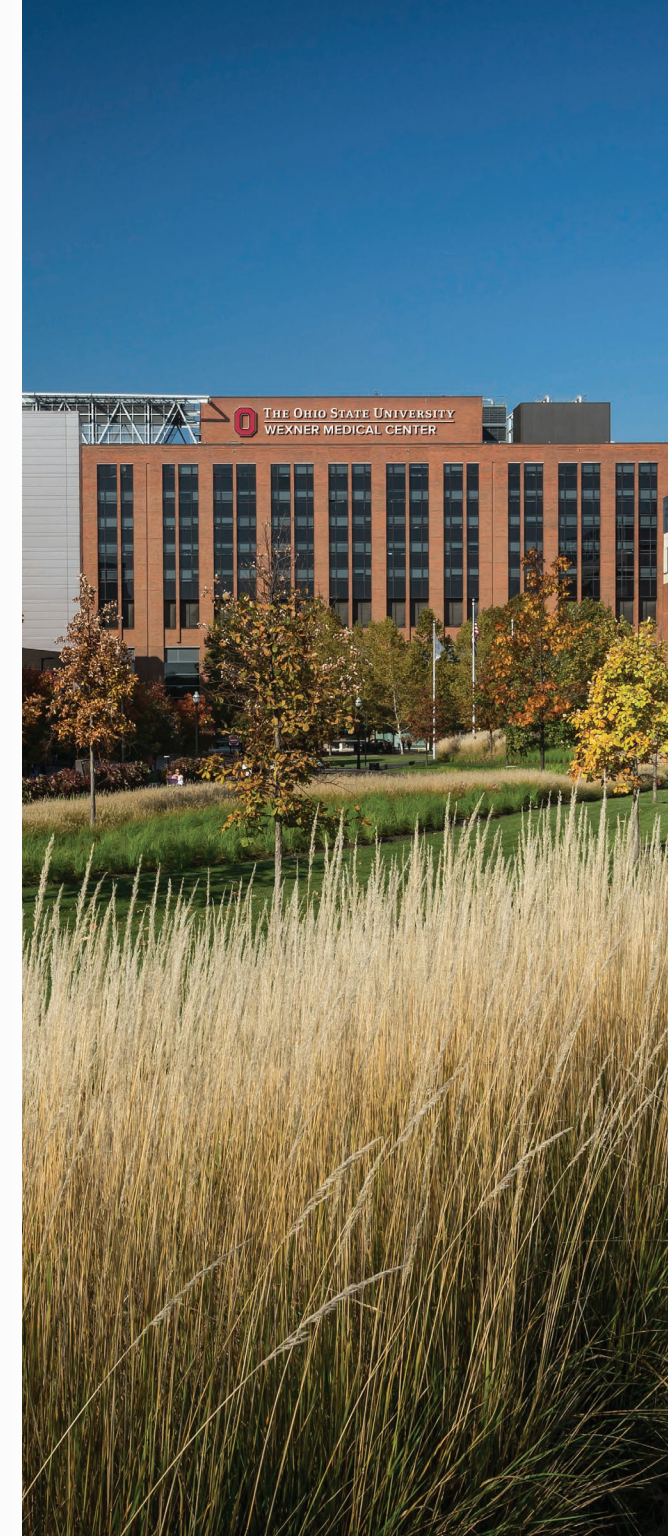

CLINICAL MISSION HIGHLIGHTS



Over the past year, the EDs were on pace to see continued clinical growth. The emergence of the COVID-19 pandemic has had an unprecedented impact on emergency departments across the country, resulting in significant declines in patient volumes, but a

significant increase in the complexity and acuity of patients seeking emergency care. The emergency departments and faculty have served an essential role in continuing to answer the call to care for any patient, anytime, anywhere in the form of surge tent preparation, telehealth visits and ongoing ED visits as the patients began to return to the EDs coming out of quarantine. Our group has been working on a number of clinical projects to improve the care for patients in our emergency departments and AfterHours care sites. Below is a list of significant projects and accomplishments. We look forward to continued improvements and ongoing innovation for the care of our patients and support of the clinical team members.

COVID-19 Response

The ED physicians and nursing staff at University Hospital and East Hospital contributed to the regional response for swabbing tent stations and surge planning. The combined efforts allowed The Ohio State University Wexner Medical Center to support the people of central Ohio and ensure that well-designed surge plan was in place for ED volumes.

AfterHours Clinics

Providers are participating in video visits to improve access for patients needing urgent care services. They've also developed a system to provide urgent care and follow-up services for COVID-19-positive patients to minimize exposures to other ambulatory clinics.

University Hospital ED

The GE AirStrip technology for digital signing of EKGs is being rolled out. The Ohio State Wexner Medical Center is the first ED in the country to implement the AirStrip app for real-time EKG review. An updated Arrival Zone evaluation process to improve efficiency of care is slated to be rolled out in the new academic year.

Oncology ED

As part of the Centers for Medicare and Medicaid Services (CMS) conditions of participation, there's a new workflow that guides staff through the ED evaluation and transfer admission to The Ohio State University Comprehensive Cancer Center – Arthur G. James Cancer Hospital and Richard J. Solove Research Institute.

East Hospital ED

The Ohio State East Hospital ED was recognized as a Lantern Award winner by the Emergency Nurses Association. This award is given to less than 1% of EDs in the country, and it recognizes exceptional practice and innovative performance in the core areas of leadership, practice, education, advocacy and research. The East ED also achieved Level 3 trauma certification, with plans to apply for Level 2 certification.

Medical Assisted Treatment Program (MAT)

The MAT program at both EDs to address opiate addiction and increased ED naloxone distribution is active in addressing the opiate abuse epidemic.

Care Innovation and Community Improvement Program (CICIP)

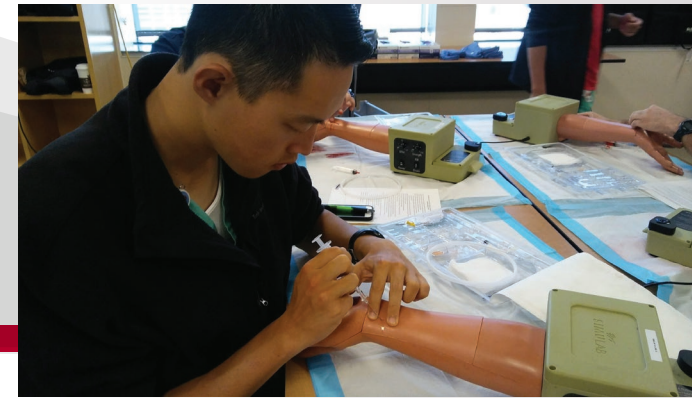
The EDs have been actively involved in working with other regional EDs to share best practices. Ohio State Wexner Medical Center EDs have been recognized for their focus on improvements in ED high-utilizer programs.



EDUCATION MISSION

This year, we continue to move forward in a number of areas. Our wellness curriculum continues, with new wellness family assignments underway and a robust list of activities led by one of our assistant program directors, Simiao Li-Sauerwine, MD, and funded in part from our Samuel J. Kiehl Endowed Chair in Emergency Medicine. Daniel Bachmann, MD, and Nicholas Kman, MD, led two virtual medical school classes in a course titled "Pandemic and Disaster Medicine and COVID-19; Response From the Bedside to the Federal Level." Three of our former chief residents, Katie Buck, MD, Carolyn Martinez, MD, and Krystin Miller, MD, rolled out a yearlong journal club curriculum that was highly successful, and the second year is underway.

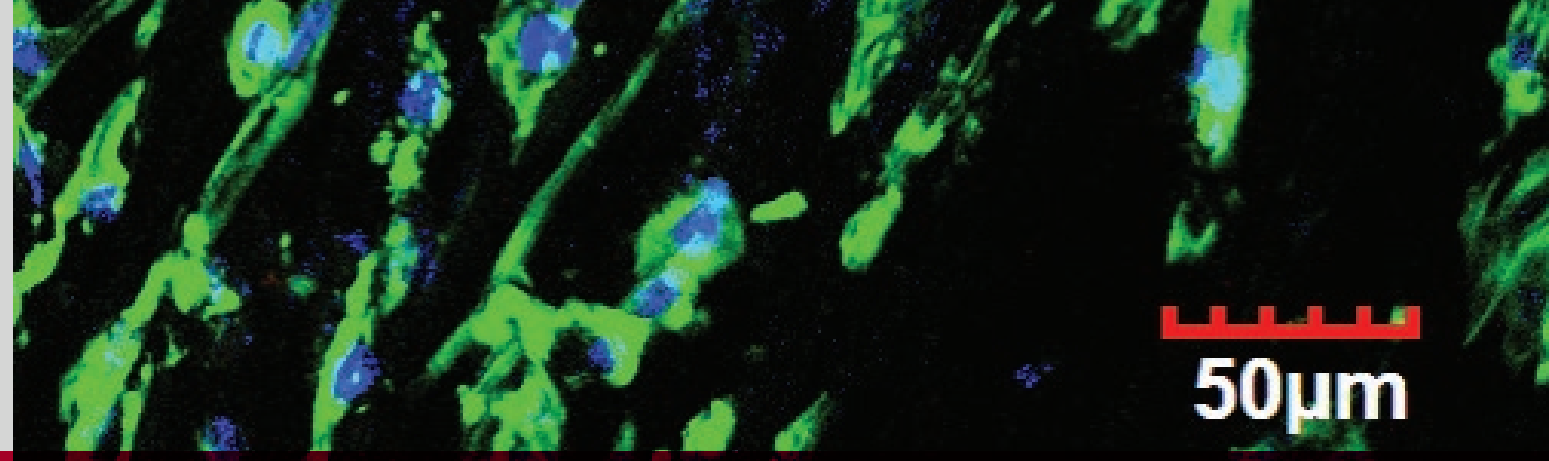
This year, our residency programs not only matched excellent classes from all over the country, we also accepted a candidate from the military match and two transfers from another EM residency program that closed (total current FY 2021 residents — 63) for the largest total number of residents ever. We also welcomed a record seven fellows into our department's fellowship programs, including two in EMS, two in ultrasound and one in medical education, administration and research for the coming fiscal year. Since the COVID-19 pandemic began, our didactic transition from in-person lectures and small groups to totally virtual has been flawless and excellent.



EDUCATION PROGRAM HIGHLIGHTS

- For the second time in three years, four female residents were elected to serve as EM chief residents for 2020 – 2021: Kimberly Bambach, MD, Natalie Elder, MD, Jacqueline Furbacher, MD, and Kelli Robinson, MD. Divyesh Mehta, MD, and Paul DeJulio, MD, are the chiefs of the EM/IM program.
- The emergency medicine residency was ranked #29 in the country by [Doximity](#).
- Jennifer Yee, DO, developed a procedure mastery curriculum for incoming first-year residents.
- A record number (9/16) of EM residency 2020 graduates plot a course for academic medicine:

- All three EM/IM graduates matched into pulmonary critical care at Ohio State: Matthew Huang, MD, Patrick Sylvester, MD, and Caleb Taylor, MD. Of our four fellows from 2019 – 2020 (EMS, research, ultrasound and medical education), three stayed at Ohio State as academic faculty members.
- Kimberly Bambach, MD, won a national Society for Academic Emergency Medicine (SAEM) award for her video presentation, “What makes academic emergency medicine the best field of medicine to practice in?”





RESEARCH MISSION HIGHLIGHTS

Clinical Research Mission

NIH-Funded Research

The EM research group continued its success, being listed #14 nationally for National Institutes of Health (NIH) funding among all departments of emergency medicine, with \$1.4 million in NIH funding. Six faculty are principal investigators or site PIs on NIH-funded research. Scholarly output kept pace with past years, with increasing publications in high-impact journals.

Leadership Announcement

Lauren Southerland, MD, was appointed director of Clinical Research. In this role, she'll have oversight of all clinical studies within the department.

New Grants Awarded

Nick Kman, MD, Jillian McGrath, MD, and Ashish Panchal, MD, are participating in an Agency for Health Research and Quality (AHRQ) study using virtual reality to train emergency personnel in mass casualty incidents. Emily Kauffman, DO, received a \$500,000 grant from the Franklin County Department of Public Health to expand our ED coordinated care program for opiate addiction.

COVID-19-Related Studies

Lauren Southerland, MD, with the assistance of research managers Jennifer Frey, PhD, and Michael Hill, RN, initiated several studies in response to the COVID-19 pandemic. These include RCTs of prophylactic therapy for health care workers (HEROES) and of convalescent plasma for high-risk COVID-19 patients well enough to be discharged from the ED (C3PO).

Ongoing NIH Studies

Federally funded clinical studies are ongoing in the areas of sepsis/ARDS, geriatric UTIs, geriatric observation care, TBI and diagnosis of pneumonia in older adults.

17th Annual Department Spring Research Day

On April 24, 2020, the Lashutka Emergency Medicine Endowed Lectureship was delivered by Elizabeth Goldberg, MD, from Brown University. She is an NIH-funded investigator and national expert on care coordination for fall prevention in older adults.

New Researcher

Katie Buck, MD, is joining the department as faculty after completing her residency and research fellowship at Ohio State. She's currently the recipient of an NIH R03 GEMSSTAR award to study improving pneumonia diagnosis in older adults.

New Researcher

Venkata Srikanth Garikipati, PhD, has joined our basic science research faculty from Temple University. He's funded by the American Heart Association (AHA) to study the role of a novel class of RNAs (circular RNAs) in cardiovascular disease.

New Research Fellow

Michelle Nassal, MD, PhD, will stay on after her Ohio State residency as a research fellow. She was chief resident, received her PhD in cardiovascular physiology from Case Western Reserve University and will be conducting translational research in resuscitation science.

Research Laboratory Mission

Our current research focuses on establishing the role of stem cells and/or evaluating cell-free products such as extracellular vesicles in cardiac repair for acute myocardial infarction (MI). We're currently studying the role of intramyocardial delivery of stem cells or biomimetic nanofiber cardiac scaffolds to repair the damaged heart. Jointly, we're also working on the reprogramming of stem cells (hiPSCs) into cardiac and endothelial lineage to repair and regenerate the failing heart muscle. Another interesting new research focus area is to evaluate the role of non-coding RNAs (both small and long) in the myocardial infarction mouse model. The next step is to translate the findings from our small animal MI model into a pre-clinical large-animal MI model, which could be utilized for clinical translation in the near future.



FACULTY DEVELOPMENT AND PROMOTION HIGHLIGHTS

Faculty development and promotion in the Department of Emergency Medicine is crucial for the success of our patient care mission, and for the success of The Ohio State University as a greater community. Our overarching goal in this realm is to shine a light on the amazing amount and quality of research, education, innovative patient care initiatives and program development. This is accomplished through a multitiered approach within the department and focused on individual successes snowballing into greater recognition of the department, both nationally and internationally. Our standing within the medical center, the College of Medicine and the university is strong and getting stronger each year.

Department of Emergency Medicine Mentorship Program

Faculty are actively involved with mentorship and sponsorship within our department and beyond to the medical community at Ohio State. The mentorship pairing allows early career development of specific areas of emergency medicine content expertise, but also aids in developing educational pedagogy, research methodology and clinical excellence standards.

Appointment, Promotion and Tenure Moving Toward Rewarding Academic Productivity in Multiple Forms

2020 saw the beginning of a revision process for the promotion and tenure guidelines for our department. The academic productivity measuring stick is changing in the world of social media, blog posts, webcasts and overall virtual connectivity. The department has incredibly productive faculty in its ranks whose work hasn't been easily translated into traditional media for distribution. A revision of the promotion and tenure guidelines hopes to recognize this work as well as many other forms of contribution to the College of Medicine and the university.

ULTRASOUND DIVISION MISSION HIGHLIGHTS

The Ohio State University Ultrasound Division within the Department of Emergency Medicine has had a productive academic year. As a growing faculty, it continues to strive for the cutting edge of ultrasound technology. The division was made up of eight core faculty during 2019 – 2020, with one fellow, Carolyn Martinez, MD, joining the US Division upon graduation. The US fellowship director is Creagh Boulger, MD, a former chief resident and graduate of the Department of Emergency Medicine. The research director of the US Division is Michael Prats, MD, a former medical student and fellow graduate of Ohio State. Lauren Branditz, MD, a former medical school and ultrasound fellow graduate leads our ultrasound educational efforts. Irene Mynatt, DO, is an ultrasound fellow graduate who leads the emergency medicine intern orientation and mentorship. Jess Everett, MD, Ohio State US fellowship graduate, is focused on medical education and helps lead the honors ultrasound advanced course for fourth-year medical students. Delia Gold, MD, is the pediatric ultrasound expert who is a leader in the Ground School (Med 3s) and pediatric emergency medicine curriculum. Daralee Hughes, MD, is a former Ohio State medical school and emergency medicine residency graduate. She published a paper this year titled “Billing I AIM” on the details of successful ultrasound imaging billing.

The US Division was active with publications, book chapters, presentations at a national meeting and with international engagement. The division had over eight publications this past year, including in *Chest*, *Journal of Ultrasound in Medicine* and in specialty journals. Division faculty participated in multiple book chapters, including on The Science of Image Generation and Gynecologic Ultrasound for the premier textbook “Emergency Ultrasound” 3rd edition. The division was well represented at the World Congress of Ultrasound in Medical Education – WCUME, held at UC Irvine in

Orange County, California, in September 2019. Multiple students and residents presented ultrasound research, while Creagh Boulger, MD, and David Bahner, MD, gave a keynote presentation on financing of ultrasound in medical education. The US Division has multiple achievements this past year, including:

- Under the leadership of Dr. Boulger, the US Division entered into a memo of understanding with the Department of Family and Community Medicine to provide ultrasound training and development of a primary care ultrasound fellowship.
- The I POCUS, or Institutional Point of Care Ultrasound committee, is led by Dr. Boulger, and is charged with implementing ultrasound best practice across the institution. This committee agreed on and implemented hospitalwide POCUS orders and developed handheld and disinfection policies at the institutional level. The I POCUS committee is working on revising credentialing documents for those scans performed by various providers across departments and service areas within the medical center.
- The GEL Podcast continues to grow across many countries and listeners. This review of the literature—Getting Evidence From the Literature—was the brainchild of Mike Prats, MD. With the help of Dr. Boulger, Jacob Avila, MD, and others, Dr. Prats has won acclaim and respect with his insightful teaching points and discussion with experts/guests to his award-winning podcast heard around the world. The podcast is coming up on its 100th episode and challenges listeners to dream

what ultrasound research will look like in the future.

- The US Division participated in the upgrade of the Q Path ultrasound documentation software to QPATH E, and brought four more units within the medical center on board with this documentation and image software solution.
- Lauren Branditz, MD, delivered a grand round presentation for the Mount Carmel Department of Internal Medicine in Grove City in November 2019.
- The division had five fellow candidates and matched two fellows for the 2020 – 2021.
- Faculty in the US Division are working on national planning committees for Sonogames (SAEM) and Sonoslam (AIUM) national ultrasound competitions.
- The US Division participated in all four years of medical student ultrasound training as well as training house staff and SICU fellows this past calendar year.

The Ultrasound Division continues to produce scholarship in medical education and case reports on how best to use ultrasound in the clinical setting. It continues to work with industry and administration to provide best clinical practice for our Emergency Department and medical center patients. Our research director, Mike Prats, MD, continues to work with our Ultrasound Research Interest Group to improve our research publication efficiency. Altogether, the Ultrasound Division continues to contribute to the Emergency Department mission, the medical center and the university with our clinical, academic and service roles.

DIVERSITY AND INCLUSION INITIATIVE LAUNCHES

DEPARTMENT OF EMERGENCY MEDICINE DOUGLAS A. RUND ALUMNI SOCIETY HIGHLIGHTS

The Douglas A. Rund Emergency Medicine Alumni Society is in its fifth full year of operation. The presidency of the society transitioned from Michael McCrea, '07 MD, to Travis Ulmer, '07 MD, at the annual business meeting, held at Ruth's Chris Steak House in Denver, adjacent to the 2019 ACEP Academic Assembly. The current slate of officers was approved at this meeting. October was the society's most active month, kicking off with an alumni tailgate sponsored by Dr. Ulmer during the Buckeye's Homecoming Football Game with Michigan State University. Shortly thereafter, the alumni society provided the incoming class of residents (Class of 2022) with alumni jackets during a special "Black Coat" ceremony. Frank Birinyi, '86 MD, was on hand to take pictures. On Nov. 4, 2019, The Ohio State University College of Medicine Department of Emergency Medicine dedicated the Emergency Medicine Residents' Community Room, made possible by a generous gift from Samuel J. Kiehl III, '71 MD. Dr. Kiehl cofounded the EM Residency Program at Riverside Hospital before moving to Ohio State to create the current Ohio State-EM Residency Program with Dr. Rund around 1980.

The arrival of the new year has been tough on everyone, including the Alumni Society and its slate of programs for the spring. The Annual Life-Long Learning and Assessment (LLSA) event planned for the end of January had to be canceled due to the illness of our beloved instructor Colin Kaide, '96 MD (now fully

recovered). Our community service, providing medical care at the annual Arnold Sports Festival, was also canceled, this time due to the COVID-19 pandemic. This service project has been organized by Brian Hiestand, '01 MD, for several years. Finally, our annual opportunity to gather socially for the department-sponsored dinner at the annual meeting of the Society for Academic Emergency Medicine was derailed due to COVID -19.

Fortunately, the Alumni Society and the department have been able to carry out a few traditions over the past year. The department held its 17th annual Research Day in May, albeit virtually, with the Lashutka (2002) Emergency Medicine Endowed Lectureship being delivered by Elizabeth Goldberg, MD, an associate professor from Brown University. Dr. Goldberg's address was titled "A Team Approach to Safe Discharge and Fall Prevention for Older Emergency Department Patients." This presentation particularly resonated with the department, which received Level 1 Geriatric Emergency Department Accreditation (GEDA) last year under the leadership of Geriatric Director Lauren Southerland, MD.

Ceremonies for the graduating class of 2020 and annual awards were also impacted by the COVID-19 pandemic. Graduates were sent off in style with a socially distanced parade held at the Ohio Stadium. Graduates drove by in the vehicle of their choice (including a pickup made to look like a bubble bath, a Ryder moving van and a brand new Tesla with gull wing

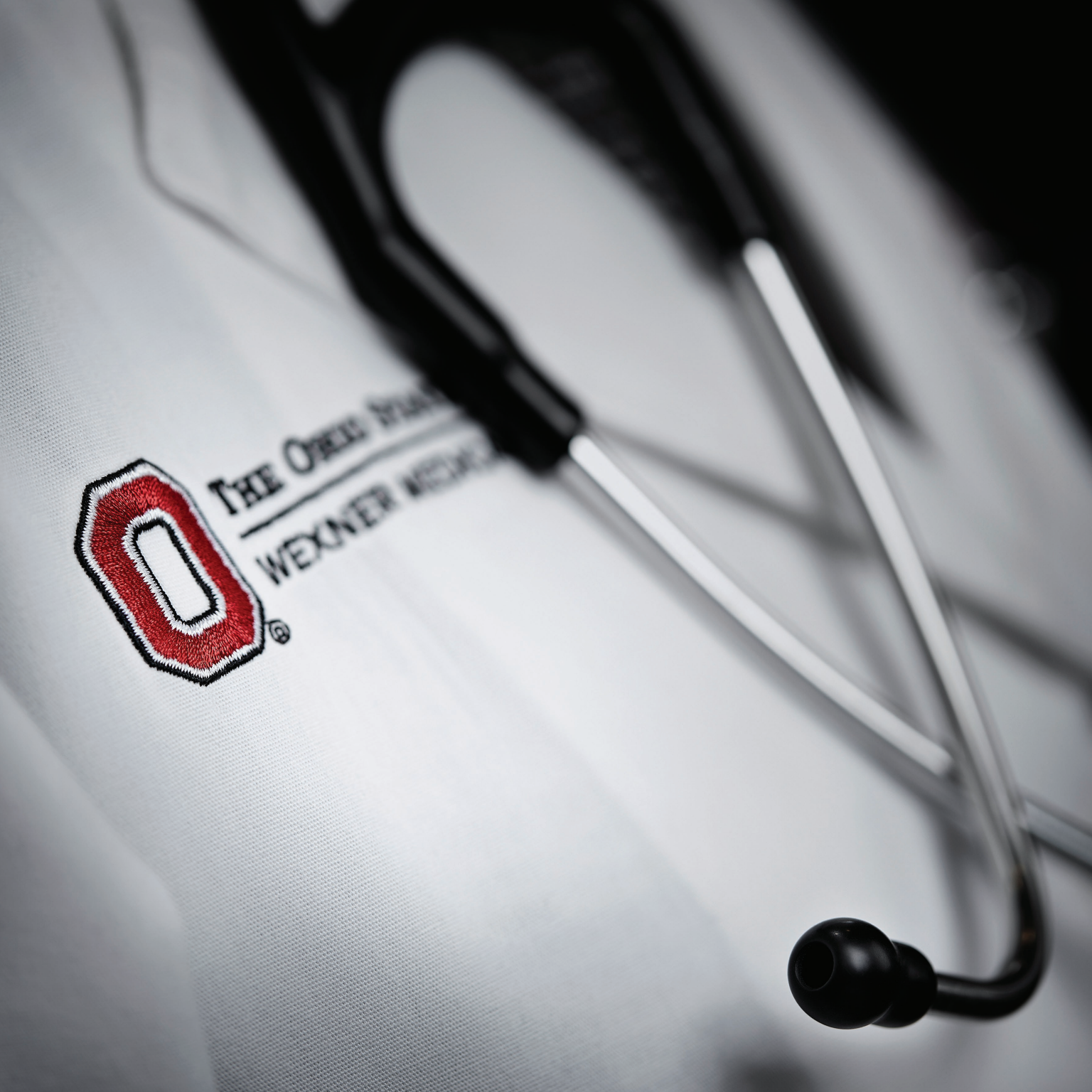
