  - Prevalence
  - Cost reduction

- Mussa Zatreh discussed TBI Mortality and Morbidity
  - o Death rate is derived from ICD 10 codes.
  - o Pike county had heist rate of TBI deaths in 2019.
  - Went over rates by age, gender, race, ethnicity, and intent mechanism.
- Abby Hagemeyer discussed Morbidity
  - Discharge data is based upon the calendar year
  - o ED visits are only counted if no hospitalization
